### ARTICLES OF INCORPORATION

OF

### J J ROCKY SALES CORP.

The undersigned subscribers to these Articles of Incorporation hereby form a corporation under the Florida Business Corporation Act.

ARTICLE I
Name of Corporation

The name of the corporation is: J J ROCKY SALES CORP.

ARTICLE II
Duration

The duration of the corporation is perpetual.

ARTICLE III General Purpose

The general purposes for which the corporation is organized are:

I. To engage in wholesale/retail clothing business.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.

3.
