SECTOR AND THE PROPERTY.

ARTICLE I

The name of the corporation is EAGLE PINES GOLF, INC.

EFFECTIVE DAIL

ARTICLE II

The corporate existence shall commence September 11, 1995, and the duration of the corporation shall be perpetual.

ARTICLE III

The general purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.
