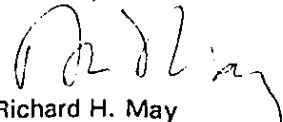

ARTICLE I
NAME

The name of this corporation is Double Gate Hunting Club, Inc. The principal place of business of the corporation is 170 D College Drive, Orange Park, Florida and its mailing address is 170 D College Drive, Orange Park, FL 32065.

ARTICLE II
DURATION

This corporation shall exist perpetually.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business relating or pertaining to providing hunting activities for its shareholders and for members of such clubs as this corporation may sponsor.

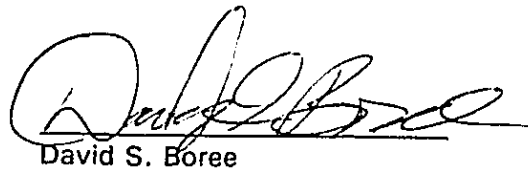
**ARTICLE VII

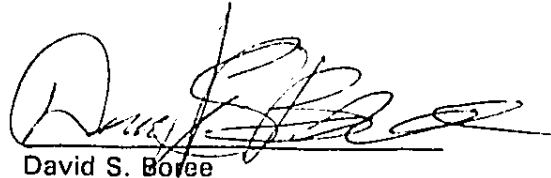
