Dear Sir or Madam:

I am writing this letter as an appeal. I am asking for a refund of the penalty for late filing of my corporation's Uniform Business Report.

At this time, TechniMark, Inc. is not an actively functioning corporation. As such I do not actively maintain office hours, and, as a result I missed the original filing date. I was not aware of the missed date until I received the second notification. I am shocked that the penalty for missing the date is \$400.00 (when the filing fee is only \$150.00). Why is the penalty so high? My corporation maintains a very small account for the purpose of custodial fees and continuance of basis in the corporation. At this time the corporate books total around \$1100.00. As one can see, paying this exorbitant penalty, will reduce the net cash of the corporation by half. I appeal to you to waive and refund the penalty. The missed filing was an oversight and an accident. I intend to eventually re-initiate operations in the near future, however, with the reduced cash will require a consideration of termination of the corporation.

I will be following-up with other members of the legislature to see if this penalty can be evaluated as to its fairness for the small business climate. A 266% penalty for missing a filing date is extremely punitive considering that there is no method for grace.
