


ARTICLE V



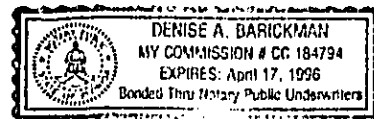
