OF

ARTICLE I - NAME

The name of this corporation is: Fastdata System Integrators, Inc..

The principal place of business is:

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.


ARTICLE VIII - INCORPORATORS




