

### ARTICLES OF INCORPORATION OF



#### PAN-AMERICAN BRAIN TUMOR CENTER, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the Corporation is PAN-AMERICAN BRAIN TUMOR CENTER, INC.

#### ARTICLE II - DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

#### ARTICLE III - PURPOSE
