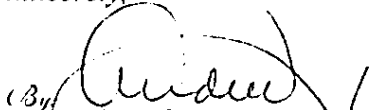

The name of this corporation is STRATEGIC DIALOGUES, INC

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

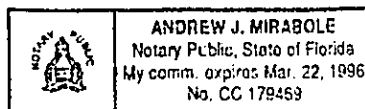
