

The undersigned Incorporator(s) hereby execute these Articles of Incorporation in order to form a corporation under the laws of the State of Florida

ARTICLE I. NAME

The name of this corporation is Street Life Productions, Inc.

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock, having no par value.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V. ADDRESS

The initial principal office of this corporation in the State of Florida is: 1126 South Federal Highway, Suite 308, Fort Lauderdale, Florida 33316. The Board of Directors may from time to time move the office to any other address in Florida.

ARTICLE VI. REGISTERED AGENT

#### ARTICLE VII DIRECTORS

These Articles of Incorporation shall be effective upon the Secretary of State accepting and filing these Articles of Incorporation.


#### ARTICLE IX. INCORPORATORS(S)

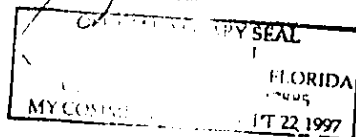
