ARTICLES OF INCORPORATION

OF

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I.

Name

The name of this corporation shall be Erik V. Korzilius, P.A.

ARTICLE II.

Address

The address of the principal office and the mailing address of the Corporation shall be:

ARTICLE III.

Term of Corporate Existence

The Corporation shall have perpetual existence unless dissolved according to law.

ARTICLE IV.
Corporate Purposes

The Corporation is organized for the purpose of engaging in the provision of legal services and any other activities necessary for the rendering of said legal services, including any or all activities or business permitted under Chapter 621, *Florida Statutes*.

ARTICLE V.
Corporate Powers

The Corporation shall have and exercise all the powers accorded corporations under the laws of the State of Florida.

ARTICLE VI.
Capital Stock

The authorized capital stock of the Corporation shall consist of 10,000 shares of Common Stock with a par value of One Dollar (\$1.00) per share. The stock of the Corporation shall be issued for such consideration as may be determined by the Board of Directors but not less than par value. Shareholders may enter into agreements with the Corporation or with each other to control or restrict the transfer of stock; and such agreements may take the form of options, rights of first refusal, buy and sell agreements, or any other lawful form of agreements.

ARTICLE VII.
Incorporator

ARTICLE VIII.
Address of Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 5629 Rustic Drive, Tallahassee, Florida 32303. The name of the initial registered agent of the Corporation at the above address shall be ERIK V. KORZILIUS, ESQUIRE. The Board of Directors may from time to time change the registered office to any other address in the State of Florida or change the registered agent.

ARTICLE IX.
Board of Directors

The powers of the Corporation shall be exercised by or under the authority of, and the affairs of the Corporation shall be managed under the direction of, a Board of Directors. The number of directors may be either increased or decreased from time to time as regulated by the bylaws.

The initial Board of Directors shall consist of one person. The names and street addresses of the one member of the initial Board of Directors of the Corporation, who shall hold office until the first annual meeting of the shareholders and thereafter until a successor or successors is/are elected and qualified or until the earlier resignation, removal from office, inability to act, or death, is as follows:

ARTICLE X.
Officers

The Corporation shall have a President, a Secretary, and a Treasurer, each of whom shall be elected by the Board of Directors at such time and in such manner as prescribed by the bylaws. The Corporation may have such other officers and assistant officers and agents as the

Board of Directors may deem necessary, to be elected by the Board of Directors or chosen in such other manner as prescribed by the bylaws. A person may hold more than one office.

ARTICLE XI.
Amendments

These Articles of Incorporation may be amended in any manner now or hereafter provided for by law, and all rights conferred upon shareholders hereunder are granted subject to this reservation.
