ARTICLES OF INCORPORATION
OF

The undersigned subscriber, he being a natural person, competent to contract for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

NAME OF BUSINESS: The name of the proposed corporation shall be GREG-JENN, INC.

ARTICLE II

NATURE OF BUSINESS: The general nature and purpose of business to be transacted, promoted and carried on by the corporation is to engage in any activity or business now or hereafter authorized or permitted under the laws of the United States and the State of Florida to be done or exercised by corporations for profit.

INITIAL CAPITAL: The amount of capital with which this corporation shall begin business is One Thousand (\$1,000.00) Dollars.

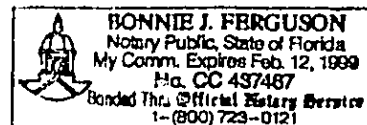
