**ARTICLES OF INCORPORATION
OF
MIAMI GRAPHICS MANAGEMENT, INC**

ARTICLE I. CORPORATE NAME.

The name of the Corporation is: MIAMI GRAPHICS MANAGEMENT, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The maximum number of shares of common stock that this Corporation is authorized to issue and to have outstanding at any one time is 1,000 shares of common stock without par value.

ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence, commencing upon filing of these Articles.
