

ARTICLES OF INCORPORATION

OF

SUPPLEE CONSTRUCTION, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms corporation for profit under Florida law.

ARTICLE I - NAME

The name of the corporation is **SUPPLEE CONSTRUCTION, INC.**

ARTICLE II - ADDRESS



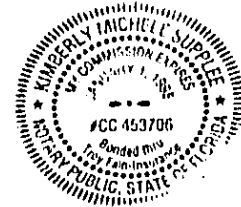
