

Articles of Incorporation

- 1) The name of corporation is: **Williams TaeKwonDo U.S.A., Inc.**
- 2) The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated under chapter 607, Florida Statutes.
- 3) The corporation shall have the authority to issue 5000 shares of common stock, in one class only, with a par value of \$1.00 each.
- 4) The registered agent shall be **G.P. Ward** and the initial registered office shall be at **11315 Woodsong Loop S. Jacksonville, FL 32225.**
- 5) The initial board of directors shall have one (2) members whose name and addresse are:
