ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional association under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be THOMAS K. PIERCE, P.A. The principal place of business shall be 154 Seashore Drive, Jupiter, Florida 33477.

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in the practice of law and may transact all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

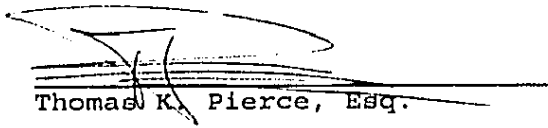
