ARTICLES OF INCORPORATION  
OF  
CORPORATE TITLE & ESCROW COMPANY

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be Corporate Title & Escrow Company. The principal place of business shall be 154 Seashore Drive, Jupiter, Florida 33477.

ARTICLE II. NATURE OF BUSINESS

The Corporation may engage in or transact all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The total number of shares of all classes which the Corporation shall have authority to issue is one million (1,000,000) shares of common stock having a par value of one cent (\$.01) per share of which one hundred thousand (100,000) shares shall be of a class designated as "Voting Common Stock" and nine hundred thousand (900,000) shares shall be of a class designated as "Non-voting Common Stock". The designations, preferences, privileges and powers and relative, participating, optional or other special rights and qualifications, limitations or restrictions of the common stock shall be identical in all respects, except that the Non-voting Common Stock shall have no voting power or voting rights, except as may be otherwise required by law.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the Corporation shall be 154 Seashore Drive, Jupiter, Florida 33477 and the name of the initial registered agent of the Corporation at that address is Thomas K. Pierce, Esq.

ARTICLE V. TERM OF EXISTENCE

The Corporation shall exist perpetually.

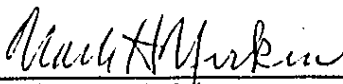
ARTICLE VI. DIRECTORS
