

ARTICLES OF INCORPORATION

I, the undersigned Incorporator, do hereby subscribe to and adopt the following Articles of Incorporation for the purpose of forming a corporation under Section 601 of the Florida Business Corporation Act.

ARTICLE ONE NAME and PRINCIPAL OFFICE

The name of the corporation shall be NETWORK BUSINESS SYSTEMS, INC., and the principal place of business and mailing address of this corporation shall be: 9906 N.W. 80th Way, Hialeah Gardens, Florida 33016.

ARTICLE TWO DURATION
