ARTICLE 1 - NAME

The name of this corporation is ELEVEN SEVENTY-SEVENTY TWO, INC.

ARTICLE 2 - DURATION

This corporation shall have perpetual existence. The effective date of this corporation shall be the date of filing.

ARTICLE 3 - PURPOSE

This corporation is organized for the purpose of transacting any, or all, lawful business.

ARTICLE 4 - CAPITAL STOCK
