ARTICLES OF INCORPORATION

ARTICLE 1 - NAME

The name of this corporation is Harbourside Properties, Inc.

ARTICLE 2 - DURATION

This corporation shall have perpetual existence. The effective date of this corporation shall be the date of filing.
