### ARTICLE I - NAME

The name of this corporation is **SYSDATA COMMUNICATIONS, INC.**

### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 830 Myrie Drive, Suite 3, Oviedo, FL 32765. The corporation may, from time to time, designate such other offices and places of business as it deems necessary to carry out its purposes.
