- FIRST:** The name of the corporation is CLASSIC DRIVE SERVICE, INC.
- SECOND:** The period of its duration is Perpetual

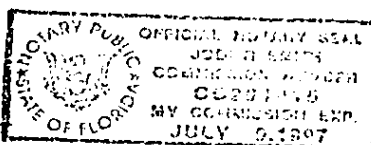
