ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS SUPERVISED MEDICAL SERVICE, INC.

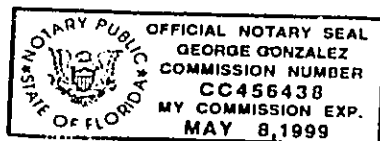
