The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation Act, hereby adopts the following Act, hereby Act Act

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE
