ARTICLES OF INCORPORATION
OF
MODERN POOL TABLES AND VENDING, INC.

The undersigned hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute §607.0202.

Article I

The name of the corporation shall be Modern Pool Tables and Vending, Inc.

Article II

The mailing address of the principal office of the corporation shall be:

Article III

The corporation is being formed for the purpose of selling, operating and servicing pool tables, cigarette vending machines, juke boxes, dart and video games, as well as to engage in any other activity or business permitted under the laws of the State of Florida.

Article IV

The amount of capital stock of the corporation shall be One Hundred (100) shares of common stock with a par value of Ten Dollars (\$10.00) per share.

Article V

The entire voting power for the selection of directors and for all for other purposes shall be vested exclusively in the holders of common stock who shall be entitled to one vote for each share of common stock held by them of record.

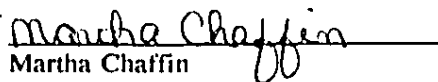
