ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, and under the status of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of incorporation for profit. It is:

ARTICLE I

The name of the corporation shall be:

EXCLUSIVE CONSTRUCTION INC.

ARTICLE II

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE III

The maximum number of shares which the corporation is authorized to issued and have outstanding at any one time is 1,000 shares of common stock, and which common stock shall have a par value of \$1.00 per share.

All stock is to be issued as fully paid and exempt for assessment.

ARTICLE IV

The stock shall be issued from time to time as may be determined by the Board of Directors.

On dissolution of the corporation, the holders of the stocks shall be entitled to distribution as their holdings may appear upon of the corporation.

ARTICLE V

The amount of capital with which this corporation will begin business is ONE THOUSAND DOLLARS (\$1,000.00)

ARTICLE VI

This corporation shall have perpetual existence.

ARTICLE VII

The numbers of directors may be increased or diminished from time to time by by-laws adopted by the stockholders, but shall never be less than TWO.
