ARTICLES OF INCORPORATION
OF

ARTICLE I-NAME

The name of this corporation is

ARTICLE II-DURATION

This corporation shall exist perpetually, commencing on the
day of signing

ARTICLE III-PURPOSE

enumerated in the Florida General Corporation Act.

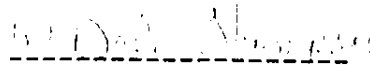
ARTICLE X-INDEMNIFICATION
