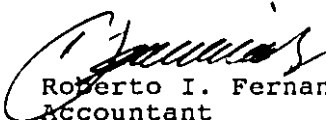

ARTICLE I – NAME

The name of this corporation is FASTCOL AIRCRAFT DIVISION, INC.

ARTICLE II – DURATION

This corporation is to have perpetual existence commencing October 1st, 1995

ARTICLE III – PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business, including exporting to Central and South America, as well as to the rest of the world, all kinds of military supplies, including aircrafts, helicopters, and their supplies and materials, and all marine vessels parts and supplies.

ARTICLE IV – CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of One (\$1.00) Dollar par value common stock. The whole or any part of the capital stock of this corporation shall be payable in lawful money of the United States of America or property, labor or services at a valuation to be fixed by the Director.

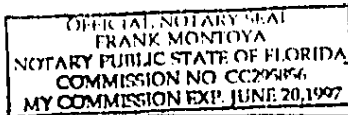
