FIVE: The registered agent and the street address of the initial registered office and principal office are the same.

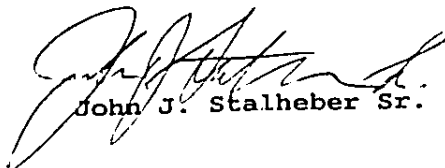

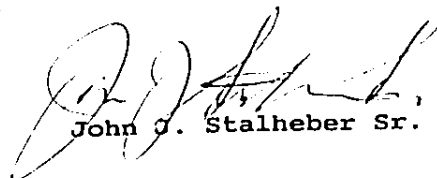

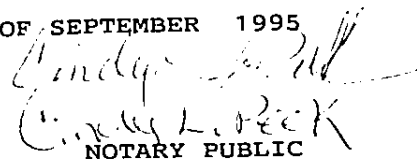
