ARTICLES OF INCORPORATION ALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts these Articles of Incorporation.

ARTICLE I - NAME OF THE CORPORATION

The name of the Corporation is: BOCA HANDWRITING EXPERTS, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence, commencing upon the filing of these Articles.

ARTICLE III - PURPOSE

This Corporation is organized for the purposes of graphoanalysis services as certified by only the International Graphoanalysis Society as the study of the individual strokes of handwriting to determine character and personality of the writer and for work in the field of questioned and forged documents. The Corporation may engage in any and all other activity which business

corporations are permitted to engage in under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock, with a par value of one dollar (\$1.00) per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
