**ARTICLE I
NAME**

The name of the corporation shall be JAKE'S BAYOU FLEA MARKET, INC.

**ARTICLE II.
DURATION**

The duration of the corporation shall be perpetual and its existence shall commence on September 22, 1995.

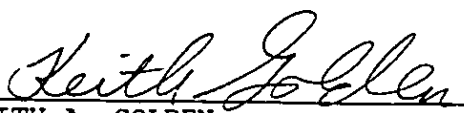

FIRST: Amendments adopted:

ARTICLE I.
NAME

The name of the corporation shall be amended and restated as follows, to wit: The name of the corporation shall be I-10 Flea Market, Inc.

ARTICLE IV.
