The undersigned, being the original incorporators of a corporation under the Florida General Corporation Act, and all other applicable Florida Statutes, WE hereby adopt and ratify the following Articles of Incorporation.

1. Corporate Name. That the name of the corporation shall be CUSTOMERS FIRST VENDING, INC.

2. Duration. That the corporation shall be perpetual in duration and shall not cease operation or its existence unless involuntarily dissolved by the Secretary of State of the State of Florida, or voluntarily dissolved by these incorporators, or their successor.

3. Purpose. That the corporation, through its incorporators and successors, is organized for any lawful purpose or purposes and shall be entitled to perform any task, operate any business, or do any thing that may be permitted under the laws of the United States of America and the State of Florida, now and as may be amended in the future.
