**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **IGUANA Software Consulting, INC** and its principal place of business shall be located at 2001 Old St. Augustine Road, M-10., Tallahassee, FL 32301.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE X - INDEMNIFICATION**


