# ARTICLES OF INCORPORATION OF OSCAR SCHULER EGG, INC.

The undersigned, acting as incorporator of Oscar Schuler Egg, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

## ARTICLE I. NAME
