EFFECTIVE DATE

ARTICLE I

The name of the corporation is ARTISTIC INTERIORS OF NAPLES, INC.

ARTICLE II

The duration of the corporation shall be perpetual, and the date and time of the commencement of corporate existence shall be September 20, 1995.


