ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation, in compliance with the statutory requirements herein, and authorize the incorporation for a profit.

ARTICLE I

The name of the corporation is: **THE OTHER SIDE, INC.**

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The purpose for which the corporation is organized is: "to engage in one or more business activities for which corporations are incorporated under the Florida General Corporation Act."

ARTICLE IV

The aggregate number of shares which the corporation is authorized to be issued is: One Hundred (100). Such shares shall be of a single class (Capital Stock), shall be \$1.00 per share par value, and shall be known as Section 1244 Stock as such stock term is defined in the Internal Revenue Code.

The whole or any part of the capital stock shall be acquired by the corporation out of the State of Florida in compliance with the laws of the State of Florida. The value of such property shall, in the event to be determined by the

Board of Directors.
