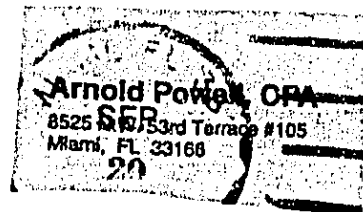

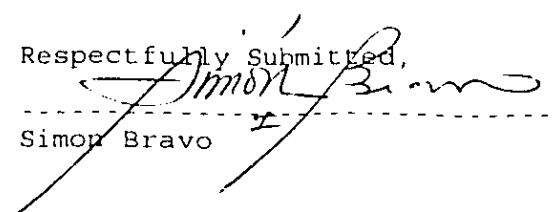

of

ARTICLE I

NAME

The name of this corporation is Rancho Bravo Inc.

ARTICLE II

PURPOSE

The existence of this corporation shall be perpetual and shall commence on the date of acknowledgement and subscription of these Articles.

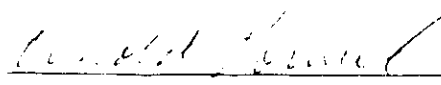

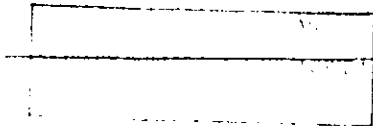

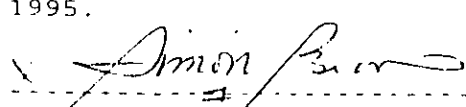
