#### ARTICLE 1. - NAME

#### ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in all aspects of purchasing and sales of new and used cars, trucks, vans and other related highway vehicles, included matineance and service, thereon, for domestic and/or for export and toengage in any and all other funcations, services and/or activities related necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
