ARTICLES OF INCORPORATION

G & H Commodities, Inc.

ARTICLE I. NAME

The name of this corporation is G & H Commodities, Inc.

ARTICLE II. DURATION

This corporation shall exist perpetually. Corporate existence shall commence with the filing of these articles with the Department of State.

ARTICLE III. PURPOSE


