ARTICLES OF INCORPORATION

OF

I, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this Corporation shall be:

ARTICLE II

DURATION

The Corporation shall commence to exist on October 1, 1995 and thereafter shall exist perpetually until dissolved according to law.
