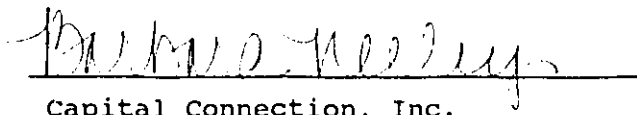

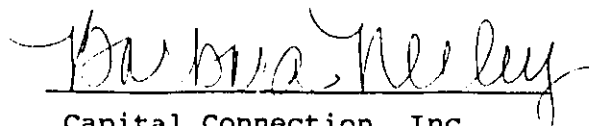

The Articles of Incorporation of INTERNATIONAL NETWORK OF FILM AND ENTERTAINMENT PROFESSIONALS, INC., a Florida corporation, shall be and hereby are amended by striking Article III in its entirety and by substituting in its place the following:

ARTICLE III: CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one million (1,000,000) shares having a par value of one mill (\$0.001) per share.
