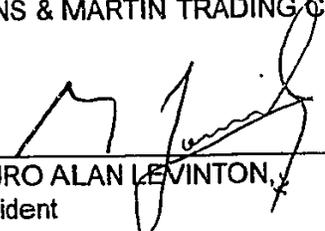

2. The foregoing instrument was adopted by all of the Stockholders and Directors of the corporation on the 4 day of December, 1996.

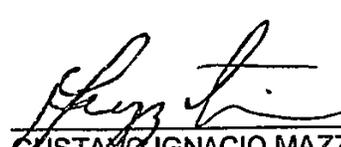
3. The number of votes cast for the Amendment by the shareholders was sufficient for approval.

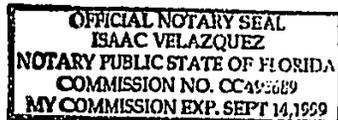
