The Articles of Incorporation of the undersigned corporation were originally filed on October 3, 1995 and assigned document number P95000076012. Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation ("Articles of Amendment"):

1. The name of the corporation is Lori Lane Enterprises, Inc. (the "Corporation").
2. "Article 1. Name." of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"Article 1. Name. The name of the Corporation is:

3. The Articles of Amendment were duly approved and unanimously adopted by the sole Director of the Corporation on November 3, 2006. The sole Director recommended approval of the Articles of Amendment to the sole Shareholder.
