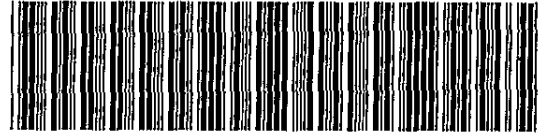

1. The new name of the corporation shall be:

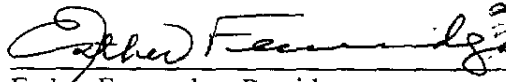

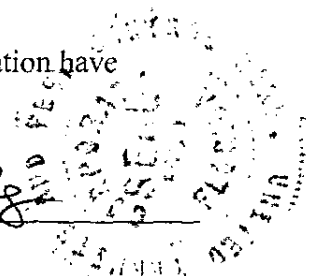
SECOND: The date of the amendment's adoption stated above is effective as of the 29th day of March, 2005.

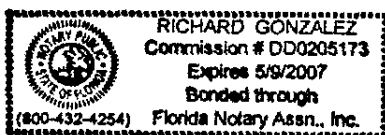
