In response to my request, I was informed the corporation was dissolved for failure to pay the annual filing fee and report.


My records indicate the report and a check in the amount of \$200.00 were received (certified mail) by your Division on May 3, 1996.

Today, I was told by your representative that the report and fee were returned for failure to include the \$25.00 late fee. This appears contradictory to the correspondence since that date.
