Here is my corporate report. *I went over all my financials & have no changes or plans. JK*

Goldie Kossow Antiques, Inc. reports a really bad counterproductive year, in which another antique shop owner, dealing mostly in furniture, invited me, a single person in business to accessorize his shop and open his shop early and to sell for him on a commission basis. I transported all my things to his shop. The first week I sold an amazing amount for a new salesperson, that is, \$28,000 worth of goods. He refused to pay me commissions and gave me notice, with the result that continuity of customer base for me has been ruined. Only 9 of my regular customers have actually found my new location.

As a result I have dropped away from making enough sales to buy new inventory and live a decent life to next to no income whatsoever.

In addition my 92 year old mother became quite ill from a severe fall. As I am the only remaining child, I have had the full responsibility for her recovery, with the result that I have not actually been in my shop and have not even had a chance to open my mail for a good part of the spring.

Therefore I am late in filing.

There is no new ownership.

However, I ask your indulgence to let me pay the fine in two parts: the first half is enclosed here and I will be done paying by July.

Things are finally looking up.
