

FIRST: Pursuant to Section 607.1003 of the Florida Statutes, the Articles of Incorporation of THRAILKILL, BROUSSARD & SMITH, P.A. are hereby amended to delete the provisions of Article I as the same now exists, and by substituting in lieu thereof, the following:
