
Pursuant to Florida Statutes, Section 607.187, the Articles of Incorporation of the above-named corporation are hereby amended as follows:

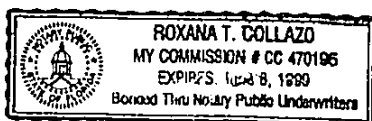

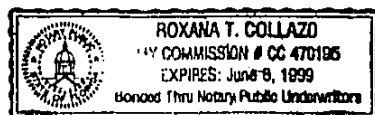
