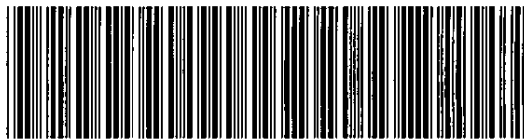

FIRST: Article 4 is amended by deleting it in its entirety and replacing it with the following:


Article 4 Shares
