#### **DOCUMENT NUMBER P95000077880**

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

FIRST: Article 4 is amended by deleting it in its entirety and replacing it with the following:

Article 4 Shares
