We are writing this letter to you to request that you accept the \$150.00 filing fee from Eckert Fine Art – Naples, Inc. for the year 2003. Circumstances beyond the control of the owners prevented a timely filing of this form and therefore, we request that you accept their original filing.

Eckert Fine Art – Naples, Inc. lost their key employee during the first quarter of 2003. That particular employee had been handling all of their corporate business for several years. The Eckerts' travel extensively in their line of business and rely heavily on their staff at the gallery to file all forms timely. Nonetheless, a new, less experienced employee in the ways of business filings was hired and for some unknown reason misplaced the first notice received from your department. When we became involved in the matter we recommended that the Company file the form immediately with the original amount due, knowing that it would prompt a letter of explanation. As explained earlier, it was outside of the Eckerts' ability to know whether or not this form was filed so they rightfully assumed that it had been timely filed.

We respectfully request that you not penalize good, law abiding taxpayers. This company has been doing business in this State for several years and never once missed the timely filing of their corporate fee to maintain a good status with the state of Florida. Please check their history with the state of Florida. Furthermore, we will oversee all state filings until the new employee becomes familiar with Florida law.
